## Chief's Report:

- Chief Sapeta reported that there are no volunteers present to provide an update.
- Chief Sapeta reported on recent fire and medical calls at Safeway, 2<sup>nd</sup> Street, Konocti View, Filmore, the Water Park, 30<sup>th</sup> Ave, 29<sup>th</sup> Ave, and in the Northshore Fire District.

- Chief Sapeta reported that the OES Fire workshop was held on 11/14/2019. The State is giving more
  control of prepositioned units to the local level to accomplish more. Along with the prepositioned strike
  team, the opportunity to upstaff our own strike team may be an option in the future for in county, and
  we would "unable to fill" for out of county.
- Chief Sapeta reported that Enloe Ambulance service is down to 1 ambulance for Colusa County. Chief Gilbert reached out to Chief Ciancio to provide mutual aid as needed all the way down to the western part of Colusa County. This means that Northshore may be responding to vehicle accidents, while Station 70 covers Station 75. Chief Gilbert is in the process of contacting AMR to try to get another ambulance service for the county.
- Chief Sapeta reported that a contract with Vertical Bridge for the cell tower may be ready by the next meeting.
- Chief Sapeta reported that the Great Shake Out table top exercise occurred on 10/18/19.
- Chief Sapeta reported that the Konocti Unified School District is working on all the mitigation for the Lower Lake High School fire alarm system. The next step is to verify the Burns Valley School alarm system and maps are up to date.
- Chief Sapeta reported that he gave a presentation on a little bit of everything at the Judges breakfast on 11/07/2019.
- Chief Sapeta reported that he continues to work on the tactical interoperable communications plan. The plan is to have one bank of frequencies for all agencies with which to communicate. Currently, CALCORD is the only channel available to all agencies.
- Chief Sapeta reported that the Christmas parade in Lower Lake is scheduled for Friday 12/06/2019, and the Lakeshore Lions Parade in Clearlake is scheduled for Saturday 12/07/2019.
- Chief Sapeta reported that he attended the annual flag lowering on 11/12/2019.
- Chief Sapeta reported that there is an ongoing problem on Ogulin Canyon Rd where the Ag Commissioner has approved cannabis operations.

## **AD HOC Committee Reports:**

- District Reorganization Director Snyder reported that they met with Chief Sapeta. The plan calls for the creation of a 40 hour Fire Marshal position. A Fire Marshal position is required by law and if staffed correctly and regularly, is a position that generates revenue. Chief Sapeta reported that the next step is to get approval to establish the positions of the EMS Liaison/Paramedic and Fire Marshal/Paramedic. Where each position will be stationed, Station 65 or Station 70, is still up for negotiations.

- 2019/2020 MOU Negotiations Chairperson Watson reported that negotiations are ongoing. There
  was an introductory meeting held on Wednesday, October 30<sup>th</sup> with a Union negotiation group. There
  are other meetings scheduled out for the next month or so with ground rules and limits for the
  meetings.
- Lexipol Policy Manual Chairperson Watson reported that she is still reviewing the manual and now has the time to work on this.
- ECC Dispatch Director Snyder reported that the committee met with Chief Sapeta last week. Director Snyder drafted a letter as a proposed form of communication. Documentation of dispatch errors must happen to prove safety issues exists. The Board is limited in its actions until the documentation supports the safety issues.
